CRYSTAL LEE JOHNSON

Crystal Lee Johnson was a vibrant red-haired dynamo who was diagnosed with a rare form of cancer at the age of 16. Despite her diagnosis, Crystal successfully completed year 12, which was a major goal for her and a remarkable achievement. She also brought happiness and laughter to the many lives she touched.

On 14 January 2019, Crystal died at home with her family by her side.

Crystal dreamed of a foundation being formed in her honour that would help young people affected by a cancer diagnosis and their families.



And so, in 2019 The Crystal Lee Foundation was formed. We are a not-for-profit community organisation, registered with the Australian Charities and Not-for-profits Commission and hold Deductible Gift Recipient status with the Australian Taxation Office.






OUR MISSION

I take immense pride in being part of an organisation that has made a profoundly meaningful impact on the lives of individuals within our local community. It is crucial to recognise that a substantial portion of our work is made possible through the dedicated efforts of our volunteers. Without their selfless contributions of time and effort, we would not have reached the position we are currently in. It still astounds me that in such a short amount of time a group of people have been able to come together with an idea and build something so special.

The Crystal Lee Foundation's Op Shop in Koroit stands as a testament to this collective endeavour. It has not only flourished but has become a vibrant community hub, where people not only seek special items to purchase but also find a welcoming environment to engage in meaningful conversations. The op shop owes its success to the tireless volunteers who have created a warm and inviting space. Importantly, it provides a stable source of revenue to fund our various community support initiatives.

Our Family Support Program continues to support four families with young members battling cancer. Over this period, we have been able to support the families with practical help including meals and lawn mowing as well provide some financial support to assist with costs incurred with travel up to Melbourne for treatment.

Our Bereavement Counselling Program has continued to deliver fee free bereavement counselling to anyone who has experienced a loss. This program is supported by donations and the money generated by the op shop, it does not receive any government funding. This program is only available because of the support of the community.

In February 2023, we welcomed Julienne Clifford to our team as the Executive Officer. She has taken on the role with remarkable dedication and has quickly made it her own. We are truly blessed to have her in this vital position.

There was also a bit of movement in the board positions. Jo Sinclair stepped down from the board and has taken on the role of Op Shop Manager. We also saw Lyn Stephens and Matthew Birtles step down from their positions. We thank them for their time on the board. We also welcomed five new board members: Katharina Redford, Rachael Gleeson, Raj Samrai, Leisa McCosh and Carolyn Roache.

I would like to thank all the staff, community members, volunteers, organisations, and businesses that have supported the Crystal Lee Foundation. Without you none of this would be possible and we should all be proud of the collective effort that has been made to make a positive difference during people hardest times.

FAMILY SUPPORT PROGRAM

It has been our privilege this past year to walk beside four young people impacted by a cancer diagnosis and their families.

The Family Support Program is difficult to describe as the support offered is entirely tailored to the individual needs and wishes of families and will change over time.

We understand the disruption to family life, education, careers and social life which can come over the course of the journey and are not just happy to assist when asked but also to offer options, information and ideas based on lived experience.

Sometimes the most valuable role our volunteers take on is to listen without judgement and with a complete guarantee of confidentiality. Our volunteers are both compassionate and practical with experience of

navigating the healthcare and associated systems and a good knowledge of what can be tapped into on the local level.

This year we have added more links to services on our website to assist families.

Whether directly, or through our website, it is a goal of the Crystal Lee Foundation to extend the support we provide and increase the families we assist.



BEREAVEMENT COUNSELLING



Demand for Bereavement Counselling services has remained strong in 2022-2023. Whilst individuals are welcome to self – refer, we are increasingly finding many people referred to us through community organisations, medical

services and government agencies. Our Counsellor, Michael has also been travelling further afield throughout South West Victoria to serve this community need with 40 clients across five local government areas, Warrnambool, Moyne Shire, Glenelg Shire, Southern Grampians Shire and Geelong. While this extension of service drives up costs for the Foundation in terms of travel, we are more than happy to assist where we can.

Counselling is open to all ages regardless of age, cause of death or when the bereavement occurred, and no limit is placed on the number of counselling sessions able to be accessed.



OP SHOP

In April 2023 the Crystal Lee Foundation Op Shop in Koroit celebrated its first birthday and continues to go from strength to strength as a place to purchase quality clothing and homewares but also as the public face of the Crystal Lee Foundation.



It is a place where we can share Crystal's story and inform people of the work the foundation does.

It is no accident that several of our referrals to Bereavement Counselling and Family Support have come as a refollow a visit to the shop, a brochure collected, or a quiet conversation with Jo and her fabulous team of volunteers.

Op Shops have an important environmental and economic role to play and the great value, the music, the shop displays and the general atmosphere attract many return customers. We are extremely grateful to those who kindly donate their pre-loved and sometimes brand new items for sale.



RAISING AWARENESS

Crystal wanted to help educate the community on the needs of teenagers in the health system which are different from those of young children and the older population. We aim to be part of the conversation in improving the experience and outcomes for young people in healthcare generally but especially for those undergoing cancer treatment. We would like to see our hospitals providing age-appropriate care in an age-appropriate environment and young people from regional Victoria able to access more of their cancer treatment locally. We are encouraged by our discussions with policy makers, hospital developers and administrators around these issues.


And we continue to tell Crystal's tory through various community engagements including presentations to the local Business and Professional Women's Group and various school groups

CRYSTAL LEE FOUNDATION INCORPORATED NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE. 2023

Note 1 - Statement of Significant Accounting Policies

These Financial Statements are a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Reform Act (Vic) 2012 and the Australian Charities and Not-for-profits Commission Act 2012. The Committee has determined that the Organisation is not a reporting entity.

The Financial Report has been prepared on a cash basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

Accounting Policies

(a) Revenue

Grant revenue is recognised in the income statement when it is controlled. When there are conditions attached to grant revenue relating to the use of those grants for specific purposes it is recognised in the balance sheet as a liability until such conditions are met or services provided.

Donations and bequests are recognised as revenue when received.

(b) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised inclusive of GST as the Foundation is not GST registered during the financial year. Receivables and payables in the Statement of Balances are shown inclusive of GST.

(c) Income Tax

The Committee believes the Association is exempt from the payment of tax under Section 50-10 of the Income Tax Assessment Act 1997. The Foundation has received income tax exemption from the ATO.

(d) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call, other short term highly liquid investments with original maturities of three months or less.

Note 2 - Events After the Balance Sheet Date

The Committee are not aware of any events that have occurred subsequest to 30 June, 2023 which would materially impact these financial statements.

Note 3 - Related Party Transactions

The Association did not enter into any contracts with related parties.

Opinion

We have Audited the financial report of the Crystal Lee Foundation Incorporated, which comprises the statement of receipts and payments for the year ended 30 June, 2023, and statement of balance at that date and the Committee's declaration.

In our opinion, except for the effects of the matter described in the Basis of Qualified Opinion section our report, the accompanying financial report gives a true and fair view, in all material respects, of the financial position of the Crystal Lee Foundation Incorporated as at 30 June, 2023, of its financial performance and its cash flows for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements, the requirements of the Associations Incorporation Reform Act 2012 and the Australian Charities and Not-for-profits Commission Act 2012.

Basis for Qualified Opinion

Income - As it is common for Associations of this type, it is not practicable for the Committee to maintain an effective system of internal control over all sources of income prior to its receipt, nor have we been provided with adequate assurance that all financial transactions have been recorded through records provided to us. Accordingly, our Audit in relation to income was limited to amounts recorded in the accounting records of the entity.

We conducted our Audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of the entity in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 Code of Ethics for Professional Accountants (the Code) that are relevant to our Audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the Audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared for the purpose of fulfilling the registered entity's financial reporting responsibilities under the Associations Incorporation Reform Act 2012. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.
